### **Who are we?**

Fife College, established under the Further and Higher Education (Scotland) Act 1992, with its registered office address as Pittsburgh Road, Dunfermline KY11 8DY is registered with the Information Commissioner's Office, registered number Z8522159.

### **What information do we collect about you?**

- Name
- Job title
- Address
- Contact details (phone number and email address)
- Booking details including dietary requirements and accessibility needs, where appropriate
- Source of referral for new clients
- Billing details and financial transaction data (including payment card details)
- Your preferences (direct marketing purposes)
- Your feedback

### **For what purposes do we collect this information?**

- To confirm your booking and related notifications
- To provide appropriate services
- To comply with legislation and associated guidelines
- To process payment in exchange for services
- To add you to our client database
- To consider concerns or complaints
- Direct marketing: to send you promotional communications
- To request feedback on your experience

### **Our Legal Basis**

**Contract:** Collecting your personal information is necessary for the booking as part of the contract we have with you, or for steps towards entering into a contract.

**Public task:** This is our additional lawful basis for handling any complaints in line with the Scottish Public Services Ombudsman Act 2002 and in accordance with the Model Complaints Handling Procedure.

**Legal Obligation:** Financial transaction data is kept in line with FCA guidelines.

**Legitimate interests:** It is in the College's legitimate interests to request and obtain feedback on your experience via surveys as your views and ideas may help to improve the services offered. Completion of surveys is optional, and you can opt-out to decline your future participation.

**Consent:** We may use your information for Marketing purposes, such as sharing the event on social media or in a press release, where you consent to this use. You may withdraw your

Substantial public interest: This is our additional legal basis for processing special category data about accessibility requirements, or other information required to comply with equalities or health and safety legislation.
