

## **Fife College Privacy Notice (CCTV)**

### **Who are we?**

Fife College, established under the Further and Higher Education (Scotland) Act 1992, is registered with the Information Commissioner's Office, registered number Z8522159.

### **What information we collect about you**

We collect personal data in the form of Closed Circuit Television (CCTV) footage and images.

### **How we use your information**

We use the CCTV, footage and images to:

- Reduce, prevent, investigate and detect crime.
- Promote public health, safety and wellbeing.
- Investigate reports of improper conduct.
- Progress insurance claims and legal issues.

The cameras currently in operation record activity at car parks, and entrances and exits to buildings the College owns or operates. CCTV cameras may be in operation in buildings owned by the College which are not fully operated or staffed. In some buildings, cameras are mounted to capture main corridor areas inside buildings near entrances, exits and fire escapes. See below for details of CCTV camera locations in the College's main venues

### **Retention**

In accordance with the College's CCTV policy, we retain CCTV images for a period of up to 30 calendar days. In some instances a longer retention may be required where a law enforcement body is investigating a crime as part of an active investigation or for another legal reason. In this instance a new retention date will be fixed for the footage.

### **Data Sharing**

We will share images with the Police as is necessary for the purposes of preventing or investigating crime or for the apprehension and prosecution of offenders. We may also share

personal data with other third parties where we are required to do so by law or where we consider we have a public task duty to do so, for example to assist the investigation of crime.

### Our legal bases

Fife College is the Data Controller for the information collected by our CCTV systems. Wherever we are processing personal information we need to make sure we have a legal basis in data protection law. Please see the table below for details of our legal bases for processing activities.
